All tenants at Jurong Fishery Port (JFP)

Visitors' Management System (VMS) – Reminder

1. Please refer to SFA's circular dated 29 August 2024. SFA would like to remind you that SFA shall implement an upgraded VMS at JFP from **Wednesday, 18 September 2024, 2pm**. With this, the VMS viz card pass shall cease on the same day.
2. Please register your particulars through the VMS online portal at (<https://vmsreg.sfa.gov.sg/>). Please visit this website to register online and encourage your employees to do so too. Kindly have your NRIC, work permit, or passport ready for registration use. Registration through the kiosks located near the security guardhouse at JFP is also available.
3. All registered particulars in the VMS are valid for 1 year only, and updating is required upon expiry. For holder of foreign passport, the registration in VMS is only valid for 24 hours. Please comply with the registration process for VMS, and to ensure accurate information are given. The list of Frequently Asked Questions (FAQs) and the instruction steps for registration in VMS can be found in Annex A and B respectively.
4. To facilitate traceability, it is crucial for users of JFP to scan his/her NRIC, work permit or passport via the scanners located at the gantries.
5. To enter the wharf area of JFP, you will need to use the physical card pass (EP card). To obtain the EP card, please apply for it with SFA's facilities management contractor (FMC – SITE Pte Ltd).

Annex A – Frequently Asked Questions (FAQs)

S/N	Frequently Asked Questions (FAQs)	Answers
Questions regarding to registration		
1	What are the benefits of digital visitor management system?	To enhance safety and security in the premises
2	How do I register? What do I need for registration? How much does it cost?	The registration can be done via registration kiosks or online (URL: https://vmsreg.sfa.gov.sg/). No charges for this registration. Registration instruction manual is included in Annex B.
3	Can I use my Driving Licence to scan in and out from JFP?	No. Driving Licences are not valid identity documents for registration, scanning in and out from JFP.
4	What is the validity for each registration?	For NRIC/ work permit holders, each registration is valid for 1 year. For foreign passport, each registration is valid is 24 hours.
5	How often do I need to update my particulars?	You are required to verify your particulars on a yearly basis.
6	How can I register online?	Please register via URL: https://vmsreg.sfa.gov.sg/ .
Questions regarding to entry/exit		
7	Is there a specific number of times a day when I can enter/exit via VMS?	There is no limit.
8	Is there a time limit for my access?	Yes, to avoid being flagged out as an overstayer, please leave the premises within 24 hours from entry.
9	Do I need to register my exit from the premises?	No registration is required. For exit, please scan your NRIC/Work Permit/QR Code via turnstile / vehicle barrier card reader.
10	What would happen if I forgot to scan out?	You will be denied entry for your subsequent visit. Please approach security staff for assistance.
11	Who can I call if I faced problem in registration?	Please approach the security staff.
12	What can I do if I forget to bring my ID for access? Can I still access?	No, you can't access. Please bring along your verification document (NRIC, work permit or passport) for entry.
Question on Tenant/ worker registration		
13	How do I register for my worker for VMS?	Refer to question 2
14	How do I register for my trade buyer who visits me frequently at JFP?	Refer to question 2

15	For new company staff, do they need to register at the registration kiosk?	Yes. Refer to question 2.
16	Do company visitors only need to register at the registration kiosks? Is there any approval required from the company.	Yes. Refer to question 2.
Buyers/ Visitors		
17	As a buyer/ visitor, do I need to register?	Yes. Refer to question 2.
Drivers		
18	I drive to JFP, how do I access the premises?	Refer to question 2 for registration. <u>For JFP</u> You can park your vehicle at the carpark lot available in front of the security guardhouse and proceed to registration kiosk for registration. After the registration, you can scan your NRIC/ work permit or passport at the vehicle barrier for entry/exit.
19	I drive to JFP and I have pre-registration access but my passenger(s) in vehicle do not. Do my passenger(s) need to alight from my vehicle and to register at the kiosk?	Yes. The passengers are required to register their particulars and scan for entry/exit.
20	Do I need to register for my vehicle car-plate number?	Yes. We encourage the registration of vehicle car-plate number.
21	Do private hire vehicle and taxi drivers need to register before entering JFP?	Yes. Both the driver and passenger are required to register.

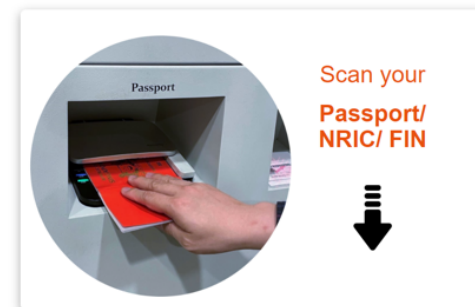

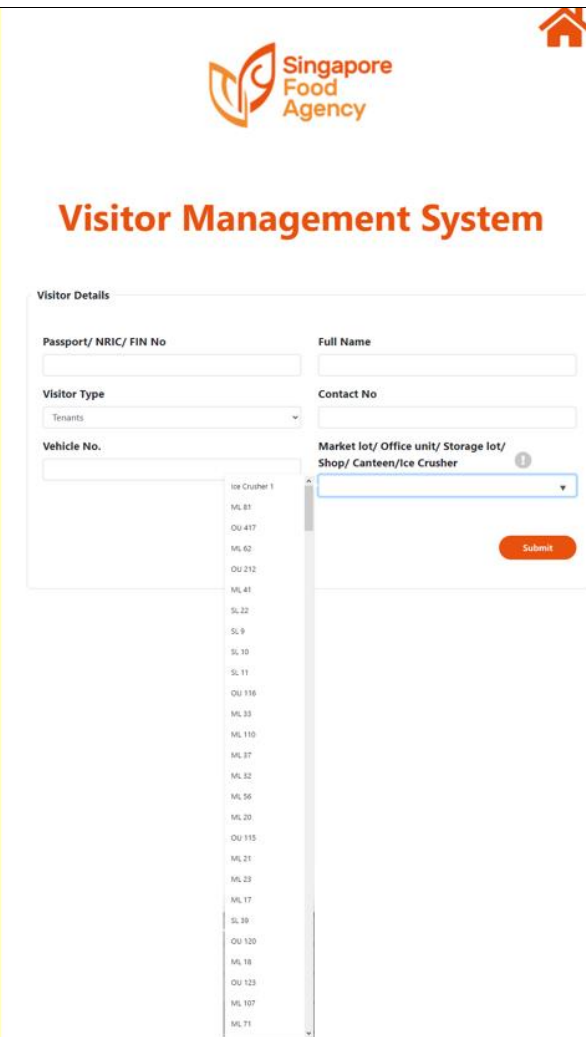
